UNIVERSITY OF VALLADOLID RESOLUTION AMENDING DEADLINE IN THE CALL FOR ERASMUS+ KA107 FINANCIAL SUPPORT GRANTS DATED 15 JANUARY 2020 ISSUED BY THE VICE-RECTORATE FOR INTERNATIONALISATION FOR INCOMING MOBILITY (TEACHING AND RESEARCH STAFF [PDI], ADMINISTRATIVE AND SERVICE STAFF [PAS] AND STUDENTS) ON THE ERASMUS+ KA107 PROGRAMME TO UNDERTAKE A MOBILITY STAY DURING THE 2020/2021 ACADEMIC YEAR.

Given the exceptional situation due to the COVID-19, the Erasmus+ National Agency in Spain (SEPIE) has granted the University of Valladolid, through the resolution dated 26 March 2020, the extension of the duration of the projects corresponding to the grant agreement 2018-1-ES01-KA107-048367.

With the aim of avoiding the inconvenience caused to those interested in participating in the Erasmus+ Programme due to the mandatory application of the third additional provision of RD 463/2020, of 14 March, declaring the state of alarm by which the suspension of administrative deadlines (subsequently resumed by RD 537/2020, of 22 May), the Vice-rectorate for Internationalisation of the University of Valladolid resolves to extend until 31 July 2021 the period of eligibility in which selected participants, both students, teaching and research staff [PDI] and administrative and service staff [PAS] at partner institutions with which pending activities can be implemented in the Erasmus+ Programme KA107-48367-Project 2018-20, extended until 31 July 2021, within the framework of the Call for Erasmus+ financial support grants for incoming mobility for the academic year 2020-21, dated 15 January 2020. In the case of the Erasmus+ Programme KA107-61356, the period of eligibility remains the same, as stated in the original document, 31 July 2021.

The present amendment entails the opening of a fresh deadline for the submission of applications from 05 June 2020 until 19 June 2020, 12:00pm Spanish time (noon).

Against the present resolution which amends errors no appeal may be filed, notwithstanding the right of the interested party, in accordance with the stipulations set out under article 112.1 of Law 39/2015, of 1 October, governing common administrative procedure for public administration, to express their opposition to the present act for its consideration in the resolution which concludes the present procedures.
