DISTRIBUTION OF SCHOLARSHIPS (2nd Call for Applications):

CANDIDATE ELIGIBILITY CRITERIA:

In order to be eligible, undergraduate, master and doctorate candidates must meet the following requirements:

Must be officially enrolled in one of the Partner universities in studies leading to a recognised degree (undergraduate, master or doctorate):

• Undergraduate candidates: must be officially enrolled in a Degree / Bachelor at the sending institution; must have completed at least one year of their studies; the area of study chosen by the students for their mobility at the UVa must be relevant to the Degree / Bachelor at their home university.

• Master candidates: must be officially enrolled in a Master at the sending institution; the area of study chosen by the students for their mobility at the UVa must be relevant to the Master at their home university.

• Doctorate candidates: must be officially enrolled in a Doctorate at the sending institution; the area of study chosen by the students for their mobility at the UVa must be relevant to the Doctorate at their home university.

Traineeships are not eligible under this project.

AMOUNT OF THE GRANT

The Erasmus+ ICM grants cover the following:

- Grant:
 - o Students (undergraduate, master, doctorate): 800 euros / month
- Academic fees at the host university
- Medical insurance: full medical insurance policy covering illness, accidents, and repatriation in the event of death.

SUBMISSION OF GRANT APPLICATION

Applications for grants should be made through the webpage <u>https://www5.uva.es/uvamobplus/</u> and the whole process is conducted <u>online</u> (applications may not be submitted by either fax or email).

In order to apply for the grant, it is important to follow these steps:

- 1. Check the eligibility criteria so as to ensure that you meet the requirements to apply for the grant.
- 2. Check the distribution of grants by countries and universities. You should also contact your university to check the priority areas
- 3. Check the courses available at the UVa. You may only apply for a grant for study programmes for the courses listed.
- 4. Check the information concerning the documents to be submitted when applying for the grant. All the required documents must be scanned and uploaded with the application.
- 5. All the required documents must be submitted in English. In order to facilitate submission of documents in English

EVALUATION OF APPLICATIONS AND AWARDING OF GRANTS

Once the period for submission of applications has concluded, home universities shall conduct a check to ensure that candidates meet the formal requirements and that documents are in order and have been submitted in full before proceeding to validate candidates. Those candidates who are validated shall then form part of the selection process.

During the first stage of the selection process, host and home universities will assess the applications. The evaluation will be made according to the following criteria:

- Academic performance (Bachelor and Master): 60% (0-100)
- Teaching / research background (Doctorate): 60% (0-100)
- Motivation (for all candidates): 20% (0-100)
- Relevance of the proposal (for all candidates): 20% (0-100)

If any academic offer has special language requirements it will be indicated the call. Language requirements are not a selection criterion but a requirement sine qua non.

If the candidate comes from a disadvantaged socio-economic background it must be indicated in the evaluation (there is a specific question). During the final selection, with equivalent academic level, preference should be assigned to students from disadvantaged backgrounds.

All candidates (selected, rejected and waiting list) will be communicated the results after Nov 15, 2017.

In order to apply for a grant, a scanned copy of the various documents described below should be uploaded. Some of these are general documents, common to all types of grant, whereas others are specific to each type of grant.

General documents to be submitted by all applicants:

- Photo
- Passport or national identity document
- Curriculum vitae, following the EUROPASS model <u>http://europass.cedefop.europa.eu/es/documents/curriculum-vitae</u>
- Letter of recommendation
- Transcript of Records (for undergraduate / master / doctorate students). In the case of undergraduate candidates, certificates should clearly show that applicants have completed the first year of their university studies
- Certificate of enrolment at the home university
- Certificates accrediting language skills.
- Signed proposal
- If you are in an unfavourable financial or social situation, you should submit documents accrediting that this is the case.
- Disabled students should submit a document as a proof of their disability
- Letter of motivation

The period for submission of applications **commences on 18 September and concludes 6 October 2017** (23:59 CET, Central European Time)
